ORDER

Now on the 3rd day of January 2024, this matter came on for consideration before the Nebraska Liquor Control Commission, notice having been served upon the licensee to appear and respond to an administrative citation alleging that the license should be suspended, cancelled, or revoked as more fully set out herein.

The licensee was present and represented by Attorney Nathan Bentley. The Commission was represented by Ken Yoho, Assistant Attorney General.

Upon consideration of all the evidence in this case, the Nebraska Liquor Control Commission finds:

FINDINGS OF FACT:

- 1. That the licensee did, on or about November 5, 2023, permit the selling, dispensing, or giving away of alcoholic liquor, to or for an individual being less than 21 years of age.

CONCLUSION OF LAW:

- 1. That permitting the selling, dispensing, or giving away of alcoholic liquor, to or for an individual being less than 21 years of age, is in violation of Neb. Rev. Stat. Sec. 53-180 and/or 237-LCC6-019.01A of the Rules and Regulations of the Nebraska Liquor Control Commission.
- 2. That the license should be suspended for a period of fifteen (15) days, with the option to pay a penalty in lieu thereof.

IT IS THEREFORE CONSIDERED, ORDERED, ADJUDGED AND DECREED that the Retail Class I Liquor License of Drive Golf & Lounge LLC, DBA – “Drive Golf & Lounge”, 414 West Ave, Holdrege, Nebraska, should be, and the same hereby is, suspended for a period of fifteen (15) days, such suspension to commence at the closing hour of business on the 3rd day of March 2024, and to continue until the opening hour of business on the 19th day of March 2024, with the option to pay a penalty in lieu thereof.

IT IS FURTHER ORDERED that the notice of suspension shall be posted upon the premises, said notice to remain posted throughout the term of said suspension.

IT IS FURTHER ORDERED that the Licensee shall pay costs of this action, assessed in the amount of \$75.00.


